## Disposal Procedures: Termite Infested Material and Soils

The removal of all termite infested material and soil must be conducted following a set of guidelines provided by the City to prevent the spread of termites beyond the existing boundaries. Residents in Guelph's Termite Management Areas are required to follow the steps below if they wish to remove any termite infested material or soil from their property:

1. At least one business day before removal of termite infested material or soil, contact City of Guelph, Building Services for an inspection at **519-837-5614**.
2. Once Building Services has inspected and authorized the removal of the termite infested material and soils, they will provide you with a **Field Report**.
3. Ensure that the individual or company (you, a friend, or a contractor) that is removing the termite infested material or soil takes the **Field Report** with them. NOTE: Trucks and vehicles without an authorized Field Report will be turned away by staff at the Waste Resource Innovation Centre or the Solid Waste Transfer Station.
4. Follow the guide below to determine where and how to dispose of your material.

| <b>Notes</b>        | Wood and soil must be unloaded by hand into the public drop-off bins for disposal.             | Solid Waste Resources staff must be notified 24 hours prior to your disposal at <b>519-767-0598</b> .  |
| <b>Restrictions</b> |  | <ul style="list-style-type: none"> <li>• The ability of the Transfer Station to accept your load is limited by its daily weight restriction (from all sources).</li> <li>• To avoid problems, drop off your load in the morning instead of the afternoon.</li> </ul> |

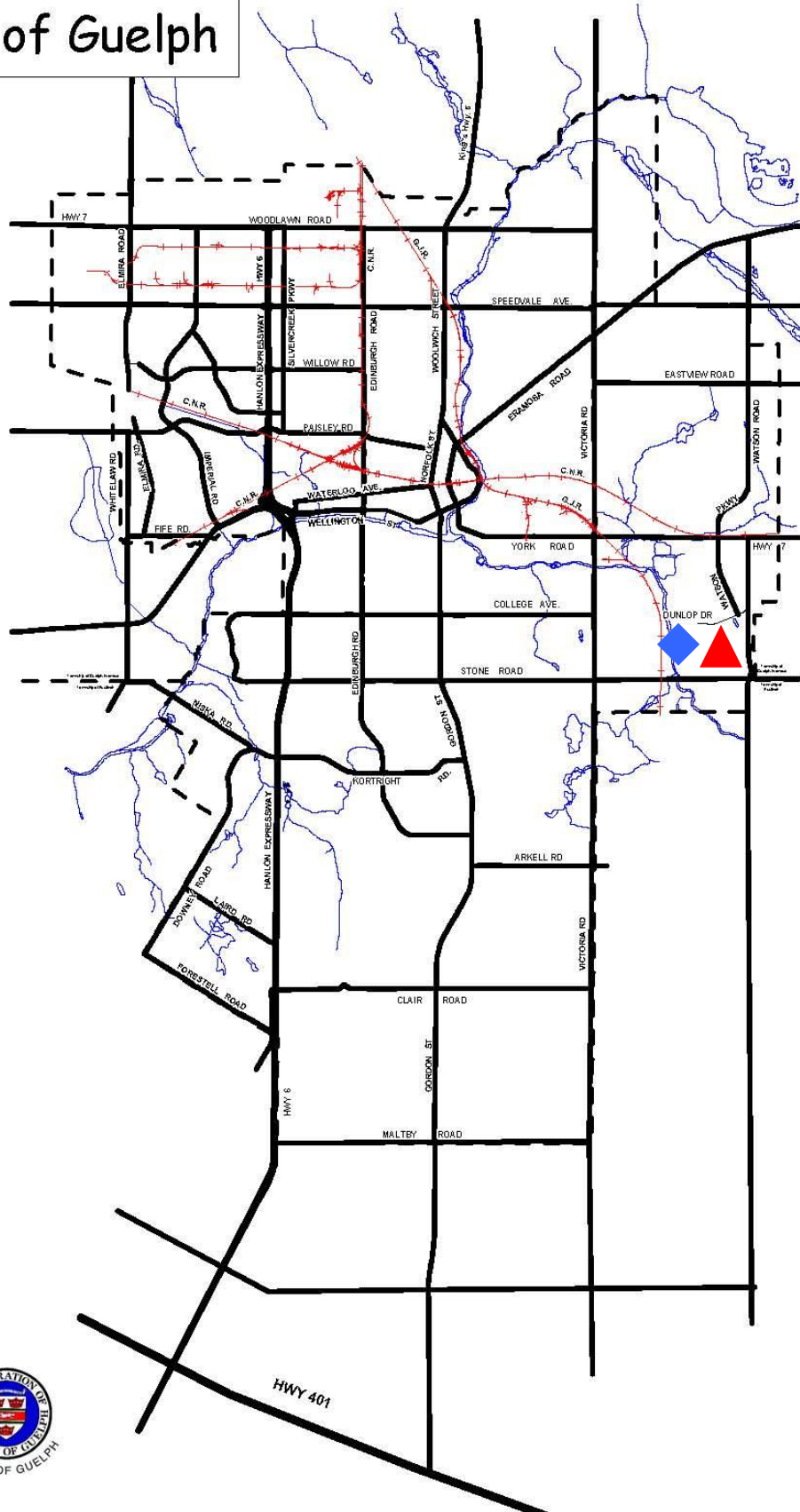
